PROF BISMARK TYOBEKA PRINCIPAL AND VICE-CHANCELLOR **NORTH-WEST UNIVERSITY**

Professor Bismark Tyobeka currently serves as Principal and Vice-Chancellor of North-West University (NWU), South Africa. Formerly the CEO of the National Nuclear Regulator and has over two decades of experience in nuclear sciences and engineering. He began his career at Eskom Enterprises, progressing through roles such as Senior Physicist and Chief Nuclear Engineering Analyst, before becoming a Nuclear Engineer at the International Atomic Energy Agency (IAEA).

He has held numerous prestigious positions, including:

- Member of the International Nuclear Safety Advisory Group
- Chairman of the Regulatory Cooperation Forum under IAEA
- President of the 6th Review Meeting of the Joint Convention on Safety of Spent Nuclear Fuel and Radioactive Waste Management

Prof Tyobeka is also an Extraordinary Professor at the Centre for Applied Radiation Science and Technology and an Extraordinary Professor of Nuclear Engineering at NWU. He is also Chairperson of the Nuclear Missile and Dual-Use Committee of the Council for Non-Proliferation for Nuclear and Biological Weapons of the South African Government and the Chairperson of the Funding Strategy Group of Universities South Africa (USAf), a body comprising all 26 public universities in South

Professor Jeffrey Mphahlele is the Deputy Vice Chancellor for Research and Innovation at the North-West University. He is a medical scientist with a PhD in Medical Virology. He is an elected member of the Academy of Science of South Africa (ASSAf). His research publications cover epidemiology, vaccination control of infectious diseases and strengthening immunisation services and policies. Prior to joining the NWU, he was the Vice President for Research at the South African Medical Research Council (SAMRC) (Oct 2014 to June 2021). He was a full-time academic at MEDUNSA (later University of Limpopo Medunsa Campus) in various capacities: Professor and Academic Chair of the Department of Virology and National Health Laboratory Service (2005 to Sep 2014) and Co-Director of the SAMRC/Diarrhoeal Pathogens Research Unit, which is a WHO Rotavirus Regional Reference Laboratory for Africa (2010 to March 2018). The rationale for diversifying the teaching awards is to embrace diversity and to create a platform for a larger group of academics to display their excellence in various fields of teaching and learning practices. More so, excellence in teaching is measured in various forms through these diverse teaching awards. Embracing diversity in the teaching awards further contributes toward the inclusion of teachers in the university community and celebrates the uniqueness of each university teacher while remaining respectful of different cultures and teaching practices.

The seven types of teaching awards include the Faculty Teaching Award, Teaching with Information and Communication Technologies (ICT) Award, Innovation in Teaching and Learning Award, Blended Teaching Award, Novice Teacher Award, Team-Teaching Award and the prestigious University Teaching Excellence Award (UTEA).

As NWU Teaching Awards are part of the rewards and recognition programme, the value of excellence in all endeavours is shared, striving towards achieving high-quality standards in all doings that meet personal, university, community, and social expectations. In doing so, the NWU Teaching Awards promote and sustain a passion among academics for continuous learning, professional development across their career trajectories, as well as innovation in teaching and learning while maintaining a positive and productive work ethic, striving toward outputs and contributions that improve the quality of teaching and learning. In addition, we use the teaching awards as an evaluative pedagogy to deepen the understanding of challenges and successes in the learning, teaching, and assessment space in the university space.

Novice Teacher Award

It is also to recognise scholars as role models of exceptional teaching. In this way, a unique set of participants, who provide leadership in teaching in their disciplines, universities and regions, are identified to ultimately act as teaching and learning ambassadors on behalf of NWU.

Research and Innovation Awards

The NWU Excellence Awards in the domain of Research and Innovation recognise outstanding achievements of various categories of academics, from young and upcoming to emerging and seasoned, including academics with new and upgraded NRF ratings. The excellent performance of postgraduate students, our next generation of scientists, is celebrated by awarding the Vice Chancellor's medal for the best master's degree student in all Faculties to acknowledge the efforts of study leaders and other academics in creating and sustaining a nurturing environment for these students. The S2A3 award for the best master's degree is granted to a student in one of the three (3) Faculties: Engineering, Health Sciences, or Natural and Agricultural Sciences.

National & International Recognition and Memberships

Acknowledgement of new & upgraded NRF ratings

This involves recognition of new and upgraded NRF ratings which demonstrates the quality and impact of research conducted by researchers at NWU.

Acknowledgement of Research Chairs

This involves recognition of newly awarded National and International Research Chairs.

Most Productive Senior Researchers

The criteria used are divided into the following broad categories: Researcher must be older than 35 years of age; DHET accredited research books, book chapters and conference proceedings Research articles published in peer-reviewed national and international journals; Presentations made to local, national and international conferences; Number of Citations; Postgraduate qualifications awarded to students; Creative outputs; Innovation output; Engaged research; Any significant research; External research funding received.

Most Productive Emerging Researchers

The criteria used are divided into the following broad categories: Researcher must be 35 years of age or younger; DHET accredited research books, book chapters and conference proceedings Research articles published in peer-reviewed national and international journals; Presentations made to local, national and international conferences; Number of Citations; Postgraduate qualifications awarded to students; Creative outputs; Innovation output; Engaged research; Any significant research; External research funding received.

Creative Outputs Award

This award recognises and rewards quality creative outputs and innovations produced according to the following subfields: Fine Arts & Visual Arts; Music; Theatre, Performance & Dance; Design; Film & Television; Literary Arts in line with DHET policy. Exceptionally high standard in terms of the output quality with a focus on originality and relevance. Awards are based on ratings by external peer review done by specialists in the fields, according to discipline-specific criteria.

Top Inventor Award

Criteria: Minimum requirements for this award: The staff member/s or student must have submitted to the TTIS at least one invention for the period under review. Notes: (1) This Award measures and recognizes a 3-year achievement cycle. Recipients will not qualify for re-nomination in a subsequent year without producing new inventions since the previous Award, in which case only new inventions will be recognised. (2) Work which has been accepted for previous awards will not be allowed in the next cycle

Innovation Impact Award

Criteria: Minimum requirements for this award: • The nominee must have been involved in the conception, development and/or implementation of at least one innovation. • The innovation must have a demonstrable impact and significance. • The nominee must have been actively involved in the commercialization or technology transfer of the innovation. 025 • The nominees may be an individual or a group consisting of employees or students of NWU. Notes: (1) This Award measures and recognizes a 3-year cycle of achievement. Recipients will not qualify for re-nomination in a subsequent year without having produced innovations since the previous Award, in which case only innovations will be recognized. (2) Work which has been accepted for previous awards will not be allowed in the next cycle.

Vice Chancellor's Award

Lifetime Achievement Award
